Minutes of the March 2016 GPLA General Membership Meeting

The March 2016 GPLA General Membership Meeting was held at the GPLA Headquarters on March 21, 2016 and was called to order at 7:32 PM by President Barry Wilensky.

Vice President Sven Hellwig who was standing in for **Sergeant at Arms** Nicholas Denaro led us off with the **Pledge of Allegiance**.

The President Barry Wilensky welcomed Paul Tyrrell from EAW Security which represents CyberLock as a guest to the membership meeting. Mr. Tyrrell presented a high level overview of the advantages of using CyberLock cylinders, smart keys and communication devices. The talk concluded at 7:52 PM.

Previous Meeting Minutes: There was a correction to the minutes as published.

Under Health & Welfare. Marty also reported that GPLA sent a donation to the Delaware Valley Alzheimer's Association in the name of recently departed and long-time member Bob Psolka. Bob Mock, Dee Mock and Marty Arnold (not just Bob Mock) attended the funeral and reported the family was grateful that GPLA was represented there.

A motion by Murray Bilker to accept the minutes as corrected with a 2nd by Cliff Shafer and was passed unanimously.

Treasurer's Report: Marty Arnold stated that the treasurer's report was presented to the Board of Directors on March 7, 2016 and was unanimously approved. Marty also reminded all in attendance that any member in good-standing may request a copy of the financial statement upon request.

Convention: Sven Hellwig noted that last week he had the first planning meeting for the GPLA convention and it was a success. Sven stated that the theme for the convention is Keeping Up With The Rapidly Changing Technology In Automotive Security and the Honorary Chairman will be Jim Hensler from Just Cars. Sven also stated that the convention will be held the last weekend in September at the Doubletree by the Philadelphia airport. It was also noted that the GPLA Convention web page is up.

By Laws: Orvis Kline proposed a motion to amend the By-Laws by adding Article IV, Section C, Sub Section 1 as printed in the Newsletter, the motion was seconded by Marty Arnold and was passed unanimously.

1. If the Quorum is not met at any membership meeting, at the following meeting, and only at the immediately following meeting, eleven (11) members having the right to vote shall constitute a quorum for transaction of business at that meeting. Notice of this meeting shall be published in the GPLA Newsletter prior to said meeting. Any legal motion supported by a majority of the members present and voting thereon, shall be deemed carried.

Education: Cliff Shafer noted that on April 9 there will be a NJ Locksmith Licensing Board approved CEU course taught by Thomas Demont to fulfill your triennial state of New Jersey mandatory licensing requirements. The course "Life Safety Codes & ADA, Means of Egress and Industrial & Shop Safety" consists of five 2 credit courses for a total of 10 credits. Cliff also noted that John Truempy and Vernon Kelley will probably be teaching a NJ Locksmith Licensing Board approved 8 CEU course in June.
