Minutes of the October 2017 GPLA General Membership Meeting

The October 2017 GPLA General Membership Meeting was held at the GPLA Headquarters on October 16, 2017 at 7:30 PM. It was noted by President Barry Wilensky that a quorum was not met.

Acting Sergeant at Arms Sven Hellwig lead us off with the Pledge of Allegiance.

President Barry Wilensky welcomed our guests Dave Jones, a friend of Paul Kline, and Ryan Harmer from Medeco.

<u>Program:</u> Ryan Harmer from Medeco gave an outstanding presentation on Medeco Classic CLIQ™ Intelligent Key System.

Previous Meeting Minutes: There were updates to the minutes as published.


