OPENING A HALL SAFE BY MANIPULATION









This beautiful looking Hall safe was brought to my shop to be opened because of a lost combination. It would be a shame to damage that door by drilling it open, so I asked Marty Arnold if he could possibly open it by manipulation. Here is how he did it.

He said the lock was a 3 wheel direct entry with stationary flies and a driver with nine false gates. First he tried it with a pointer and used a bungie cord to put consistent tension on the handle trying to obtain a indication on one of the 10 gates on the driver. When no reliable reading showed up on the pointer, he attached a laser to the handle with hose clamps and took laser readings on a sheet of paper he taped to a box about 5 feet away as shown on the small picture.

He found the numbers for the 3rd and 2nd wheel gates with his laser setup but could not find a positive indication for the 1st wheel gate. So proceeded turning all wheels, progressing 3 numbers at the time, followed by dialing the numbers for wheel 2 and 3. Just like dialing for dollars Rex Parmalee use to say in his manipulation class.

But this was not like dialing for dollars like on a 6730. He had to dial every one of those combination to all 10 gates in the drivers as there is no way telling which one was the opening gate. Picture on the Right shows the bungie cord pulling the handle down when he came to the opening gate and the safe was open without any damage.
