


50/50: The amount of \$55 as well as other various prizes were won.



ARNOLD'S PERMUTATION LOCK

Mr. Fred E Arnold patented his permutation (changeable combination) lock back in 1883. This Chicago Illinois inventor designed a rather unique functioning lock. The lock contained three wheels. Each wheel had a thin slot or what we call today, a gate. A row of gear teeth notches make up the outside edges of the wheels. This arrangement may have unknowingly thwarted the



use of the modern manipulation attempts. A tapered nose of a spring loaded pawl engaged into the notches of the wheels. I assume, to preventing the dragging of one wheel by the movement of another and holding a wheel to its combination position. The wheels did **not** have 'drive pins'.

The shaft or dial spindle, passed though the lock case and through slightly oversize holes in the center of the wheels. Each wheel has a short slot milled outward from the center hole. In the area of the wheel pack, the spindle had a metal pin. This protruding spindle pin fit into the milled wheel slot and provided the connection between the spindle and the wheel. The pin engaged only one wheel at a time.

The spindle was designed with end play. By pushing the spindle all the way in, it would engage the back wheel and it could be set to a combination number. When the dial was pulled out slightly to an indicating notch, it would engage the second wheel and it could be set. The final wheel was set in the same manner. By moving the dial/spindle either in or outward, the operator

could run the combination and align the wheel gates to the 'fence'.

Here is the part that blew me away! The dial spindle and wheels are all attached to the locking bolt! The safe door and lock case are slotted, so the spindle can slide horizontally. If the spindle slides, so does the wheel pack. Because it is connected, the lock bolt moves also. In other words, the fence doesn't move into the wheel gates, the wheel gates slide into the fence!

Look at the lower illustration. This depicts the locked position. Note the empty area to the right of the wheel pack. This is where everything slides, to open the lock. A changeable combination lock? Each wheel had a random positioned gate slot when matched with the center hole milled slot. Wheels could be switched or turned over and change the lock's combination.

Apparently Mr. Arnold didn't impress any safe manufactures. I don't recall seeing his lock on any safes. Did you?

Bill Would Impose Significant Apprenticeship Requirements on New Jersey Contractors

On December 17, 2018, the New Jersey Legislature paved the way for a game-changing prerequisite for N.J. public works contractors. The State Assembly and Senate passed Assembly Bill A-3666 and forwarded it to Governor Murphy for his signature. If signed into law as is expected, the bill—which would impose new apprenticeship and training requirements on public works contractors—would be among the most restrictive of its kind in the country. Governor Murphy has until the end of January to sign the legislation, which would become effective 90 days thereafter.

What Are the New Contractor Obligations?

The bill, which blazed its way through the lawmaking process, would require a contractor to certify its participation in a U.S. Department of Labor (DOL)-approved apprenticeship program in order to obtain or renew its public works contractor registration certificate. Further, apprenticeship programs would have to include training for every classification of worker a contractor employs on a public works jobsite. Thus, if a contractor employs workers in a single job classification, participation in a program limited to just that one classification would suffice. If, however, a contractor employs workers in multiple classifications on a covered job site, the contractor would have to certify participation in an apprenticeship program that encompasses each and every such classification.
