

REGISTRATION INFORMATION

The Greater Philadelphia Locksmiths Association is committed to preventing illegal locksmiths from taking the classes we offer during our convention. If you were previously registered for any of our last 5 conventions (beginning in 2014), we will have your documentation on file.

If you are not a GPLA member and **HAVE NOT** attended within the last 5 years, you must include the following:

- A copy of a *current* membership ID or certificate showing expiration date from any of the following associations: ALOA, SAVTA or ILA

OR a copy of any one of the following:

- Your current State of New Jersey Locksmith License (required for those seeking CEU's)
- Your employer's current New Jersey Locksmith Business License
- You or your employer's current PA Home Improvement Contractors License
- You or your employer's PA Certificate of Registration Sales Tax License
- You or your employer's Delaware State Personal Services General Repair Person Business License
- Locksmiths from other states must provide a copy of your locksmith license (if applicable) or a state certificate of authority to collect sales tax.

OR

If you are an in-house locksmith or employee of a private firm, institution, government agency or organization, please provide ***both*** of the following:

- Copy of your employee ID
- Company check, Purchase Order or letter from your supervisor (if you are paying with a personal check or credit card) with your supervisor's contact information stating that you are attending as a function of your job.

Registrants attending *only* the Product Exhibit, as well as all GPLA members and their employees are exempt from the requirements listed above.

All attendees must show a state issued photo ID to pick up their registration packet.

GPLA reserves the right to remove any attendee found to be in violation of our Code of Ethics from classes or the Exhibit floor

Please use one form for each student except for those attending only the Product Exhibit.
