Minutes of the November, 2022 GPLA General Membership Meeting

A GPLA General Membership meeting was held on November 21, 2022 at GPLA HQ. Prior to the meeting, a traditional Thanksgiving meal was served, prepared by S. Hellwig, Sr, along with side dishes provided by various members.

The meeting was called to order at 7:33 PM by President S. Hellwig, Sr.

The President introduced 3 guests: Martin White, Matt Marcinkowski, Roland Cooper, Scott Cordaine.

The President turned the floor over to Roland Cooper and Scott Cordaine of Banner Solutions, who presented a program on various product lines available through Banner Solutions

<u>Previous Minutes:</u> Motion to accept the October 2022 minutes as printed in the November 2022 Newsletter by J. Reustle, second by J. Handschuh. Motion passed unanimously.

<u>Treasurer's Report:</u> M. Arnold reported that he had presented the Operating Account and Convention Account reports from September 1 through October 31, 2022, as well as the 2022 Convention Financial Report at the November Board meeting and reminded everyone that copies of all financial reports are available to all members in good standing upon request.

Onraet reported that he had received new applications for membership from Dan McGlynn and Martin White, and that he would be presenting his report on them to the Board at the next Board meeting. M. Onraet also reported that the Board had approved the application of Anthony Wiersielis, who is the ALOA NE Director. Because of his status as a VIP, the Board voted to forego the usual vetting process for Mr. Wiersielis, including the requirement that he attend 2 membership meetings prior to being voted on.

Education Committee: C. Shafer reported that no classes were currently being planned until Spring of 2023.

Health & Welfare Committee: No new report.

<u>Building Committee:</u> M. Arnold reported that there were no new issues to report.

Communications Committee: P. Kline reported that continues to send out Constant Contact e-blasts as needed, or as directed by the Board.

Newsletter: M. Arnold reported that the November newsletter was sent out in a timely fashion, as usual.

Website: M. Arnold reported that the new pictures from this year's convention were up, including all Award recipients.

Licensing and Legislation: No report.

<u>Convention Committee:</u> S. Hellwig announced that there would be no convention in 2023 so that the committee could spend extra time planning to make our 75th Anniversary Convention in 2024 extra special. S. Hellwig also reported that the committee was looking at possible dates in the Spring or Fall of 2024.

S. Hellwig thanked P. Kline for his past efforts in arranging for meeting programs over that past 3 years.

Onraet reported that the Board was discussing a change in the Bylaws regarding the minimum length of time that an Active or Associate member must have been a member before a member can serve as an Officer or Director. M. Onraet reported that he would present his proposal at the next Board meeting.
