

The membership voted to accept Ken Kramer as an Apprentice member. His number will be 305



#### Minutes of the May, 2022 GPLA General Membership Meeting

A GPLA General Membership meeting was held on May 16, 2022 at GPLA headquarters. There were 13 members in attendance and constitutes a quorum per the Bylaws after the previous (April) meeting did not meet quorum attendance. The meeting was called to order at 7:20 PM by President S. Hellwig, Sr. The President introduced the following guests: Bob Chartrand, Tim O'Connor and Michael Luciano of Chartrand Associates, and John DePew.

This month's program on products from Command Access and from Torus was presented by Chartrand Associates.

Previous Minutes: Motion to accept the March 2022 minutes as printed in the April 2022 Newsletter by M. Arnold, second by D. Barnum. Motion passed unanimously.

Treasurer's Report: M. Arnold reported that the Board had approved the Treasurer's Reports from March 1, 2022 through April 30, 2022 and reminded everyone that a copy of all reports are available to all members in good standing upon request.

<u>President's Report:</u> S. Hellwig, Sr. reported that he has presented some ideas to the Board for getting GPLA's name in front of the public, including a PSA and a program like The Angel Network. 


